Course connections (prerequisites, parallelis):

Aim and principles of the course:

To support the research project of the theoretical background and utility of the diploma work. The precise purpose is to provide the thesis written.

Learning outcomes (professional and general competences to be developed):

The student will have a sufficient understanding of the subject area of research to be able to formulate and analyse broad, specific contexts.

- is familiar with several specific methods of knowledge acquisition, research and abstraction;
- selects and formulates alternatives based on the weighting of the problems encountered and the evaluation of the outcomes of possible solutions;

skills

- The student is able to compare different critical approaches, to analyse them from multiple perspectives and to develop his/her own professionally formulated critical opinion.
- The ability to communicate research findings in a fluent and articulate way (written, visual and otherwise), without having problems with code-switching.
- Appropriately use the language of the field and its rules of reference, citation, copyright and ethics in written, oral and visual communication
- Ability to work with large amounts of foreign-language literature and texts.

- The student will act autonomously in his/her real research project, both in identifying and planning the resources needed for the solution, in critically analysing the sources and in carrying out the research.
- Understands the difference between general and professional ethics; acts according to the ethical standards of scientific research.

Topics and themes to be covered in the course:

Tamás Berky's thesis course is primarily open to applicants, who are interested in the following topics:

- General characteristics of mental health, possibilities of its development
- School and workplace mental health
- Relationships between participants in the educational process, causes and management of potential conflicts
- Skills training in education and the workplace
- Pre-agreed topics related to the above

Specificities of process organisation / organisation of learning:

The small course alternates between group learning and individual consultation.

The submission of the final thesis is timed to coincide with the central thesis submission deadline.

Students' tasks and responsibilities: to complete the course, it is essential that students attend the consultation sessions and introductory classes scheduled at the beginning of the semester. The submission of the completed thesis will be timed to coincide with the central thesis submission deadline.

Learning environment: consultation held in classroom/online/out-of-class, by agreement

Assessment:

Evaluation of the student's performance is continuous, progressive from consultation to consultation. The grade at the end of the semester is based on the preparation of a thesis plan suitable for submission and the quality of the completion of the tasks set for the consultation dates.

Method of assessment:

Students who successfully defend their thesis in the pre-presentation, attend the consultation sessions and complete the sub-tasks according to the pre-agreed schedule will receive an excellent mark.

The course will end with an unsatisfactory grade if the student fails to complete the thesis prepresentation or the post-presentation after a failed pre-presentation.

The course will be marked as incomplete if the student does not participate in the consultation work and does not submit a thesis for the pre-presentation.
